County Updates

Coconino County has one new Supervisor and the new County manager will start on August 5; they have had an interim management team for 18 months.

Maricopa County had two new Supervisors elected – Max Wilson resigned and appointed a new Supervisor. They have three new Supervisors.

La Paz County has two new Supervisors.

Pinal County has four new Supervisors and an Interim County Manager; they just went from 3 to 5 member board. All new Elected Officials except for one.

Gila County has one new Supervisor, a new Assessor and a new County Attorney. **Pima County** has one new Supervisor.

Yavapai County has three new Supervisors and a new County Administrator; they just went from a 3 to 5 member board.

Navaio County has two new Supervisors.

Santa Cruz County has the same three Supervisors and one new Elected Official, Treasurer.

Cochise County has the same three Supervisors and one new Elected Official. Katie has retired as Clerk of the Board and they will be hiring to fill her position.

ACCA Bylaws review

Robin Brigode made a motion to strike the second sentence of Article V Section 1 "The President must be a Clerk of the Board of Supervisors"; motion seconded by Anna Wayman-Trujillo. Vote unanimous approving the motion.

Melinda Meek made a motion to change the second sentence in Article VI to read "Dues are payable in July of each year"; motion seconded by Marian Sheppard. Vote unanimous approving the motion.

Tax Deeded Land Auctions/Sales Process

Melissa gave a presentation on Navajo County's process of On Line Auction. Please see the attached presentation.

Discussion was held regarding ARS §42-18124

42-18124. Compromising taxes, interest and penalties; omission of tax or fund from action for collection

A. If it appears to the board of supervisors that any property is not worth the amount of taxes, interest, costs and penalties due or that the tax lien on the property would not sell for that amount, the board may compromise the taxes, interest and penalties with the owner or with the holder of a certificate of purchase that was issued pursuant to section 42-18118.

In some counties the County Engineer and Assessor look over the back tax land list to see if the County may want that parcel. Pursuant to statue counties may sell real property to the county or a city, town or special taxing district in the county. See ARS §42-18303 E

42-18303. Auction and sale of land held by state under tax deed; disposition of proceeds

E. The board of supervisors may accept an offer from, and sell real property held by this state by tax deed to, the county or a city, town or special taxing district in the county for a public purpose related to transportation or flood control. The board of supervisors shall convey the deed and apportion the monies received in the transaction in the manner prescribed by this section.

Melissa will invite Public Surplus to our next meeting.

Training Opportunities for County Clerks & Succession Planning

Discussion was held regarding training opportunities for County Clerks. The Certified Municipal Clerk / IIMC (International Institute of Municipal Clerks) annual membership fee is about \$150.00 and you have to be a member for 2 years before you can apply. You also have to have 60 education points and 50 experience points. Points can come from being an officer, years as a Clerk, years in government, annual conference hours as well as AACo Conference hours.

Further discussion was held on AMCA, ARMA (American Records Management Association), CPM (Certified Public Mangers), and MPA programs / Master of Administration.

Discussion was held regarding our own County Clerk Certification. Wendy will email everyone the "History of the Clerks". Wendy will also email out some topics for certification.

Fran will email everyone the 365 statues that name the clerks, a document that was given out at a conference a long time ago.

Ana will take on coming up with a curriculum for our own certification.
