Introductions & Welcome

Procedures for Board of Supervisors' Annual Sale/Auction of Tax Deeded Land

Marian stated that she will email out to everyone Gila County's sealed bid procedures. Barbara stated that in Mohave, the beginning price is half to encourage the sale so the property gets back on the tax roll.

Election Processes and Responsibilities

A roundtable discussion was held regarding Election Certificates, Oath of Offices for those who are appointed and the possibility of the legislature repealing the requirement.

A discussion was held regarding the new legislation regarding fireworks in Arizona. Fran requested that any county that has a fireworks ordinance or procedures for firework permits send it out to the other counties via email.

A discussion was held regarding how the staffing levels for each Clerk of the Board has been affected by budget cuts and what the scope of duties are in each office. A discussion was held regarding the Call to the Public and if the Board of Supervisors meetings are broadcasted via the internet or television.
